- A. Have been convicted of any of the offences referred to in Part IV, paragraphs 2, 4, 5 and 7; In Title V, paragraphs 4, 5, 6, 7, 8, 9 and 10; In Part VI, paragraphs 5, 7, 8, with the exception of the provisions of article 288 bis and paragraph 14; And Title IX, paragraphs 7 and 8 of the Second Book of the Penal Code; Decree with force of law No. 1, 2004, of the Ministry of Economy, Development and Reconstruction, which establishes the consolidated, coordinated and systematized text of Decree Law No. 211 of 1973; Offences under the Tax Code; The Code of Military Justice; Or the offences contemplated in Decree with force of law No. 30 of 2004, of the Ministry of Finance, which approves the consolidated, coordinated and systematized text of Decree with force of Finance Law No. 213, of 1953, on Customs Ordinance.
- B. Register one or more tax debts for a total amount greater than 500 monthly tax units for more than one year, or more than 200 monthly tax units and less than 500 monthly tax units for a period of more than two years, without there being a payment agreement in force. In the event of a pending judgment on the effectiveness of the debt, this incapacity will be effective once the respective resolution is final or enforced.
- c. Register pensions or health debts of more than 12 months for their dependent workers, which will be accredited by a certificate from the competent authority.
- D. Have submitted to the Special Registries of Suppliers of the defense sector one or more documents declared false.
- E. Be subjected to an insolvency proceeding referred to in Law No. 20,720, to a bankruptcy proceeding or to the dismantling of their assets.
- F. Have been convicted of anti-union practices or violations of fundamental workers' rights.
- G. Be within any of the circumstances provided for in Article 8, paragraph 2, and Article 10 of Law No. 20,393, i.e., subject to a temporary or perpetual prohibition of acts and contracts with state agencies.
- H. Provide personal services in the agency or institution in charge of the respective registry, as an official, worker or fee contract.
- I. Have a relationship of marriage, adoption or kinship up to and including the third degree of consanguinity and the second degree of affinity with the authorities, directors or senior officers of the agency or institution responsible for the respective registration. For information, the respective agency or institution must identify the authorities, managers or authority referred to.

- J. To have among its members, in the case of associations; Among its shareholders, in the case of limited partnerships and corporations; Among its shareholders who own 10% or more of the capital, in the case of public limited companies; Or among the managers, administrators, representatives or directors of any of the aforementioned associations, any person who has any of the conditions mentioned in this subsection or who is affected by any of the circumstances indicated in the final paragraph.
- K. Have the status of the accused or accused against whom the investigation has been formalized, with respect to one or more offences referred to in paragraph (a) of this article, in accordance with the provisions of articles 274 et seq. of the Code of Criminal Procedure, 229 et seq. Of the Code of Criminal Procedure or in the Second Book of the Code of Military Justice.
